The Company has received favorable orders from the MVAT Tribunal [previously Maharashtra Sales Tax Tribunal (MSTT)] for the periods 2007-08 to 2015-16 and 2017-18, while the department has appealed against the said orders before CESTAT [previously Central Sales Tax Appellate Authority, Delhi (CSTAA)]. For 2016-17, the Company received a favorable order from MVAT Tribunal. Based on legal advice and favorable precedents, the Company has not made any provision in its books of accounts, as the likelihood of an economic outflow is considered remote.	There was no change in the status of litigation during quarter ended 30 June 2025. However, it is pertinent to note that on 11 July 2025, The Company received favourable order from CESTAT for the period 2007-08 to 2015-16 and 2017-18 (9 out of 10 years). For the year 2016-17, Maharashtra Sales Tax Department has not contested the order of MVAT Tribunal. The litigation is now being treated as closed.
